

ADVENTURE DAY TERMS AND CONDITIONS

Adventure Day – Terms and Conditions

1. Peat Rigg reserves the right to cancel or modify our courses due to safety considerations and/or factors beyond our control.

Booking

2. Bookings will be confirmed upon receipt of your payment in full and completed booking form.
3. If payment hasn't been received, then Peat Rigg has the right to offer the place to another organisation or party.
4. Fees will apply if unexpected participants are present on the day of your course.
5. Any false or misleading information through the booking form may result in cancellation of your course with no refund.

Cancellations

6. Cancellations will have to be arranged via contact with Peat Rigg
7. Charges will not apply if your course is cancelled with more than a month's notice.
8. In the unlikely event of a course being cancelled by Peat Rigg, all monies will be refunded, or you may choose an alternative course.

Liability

9. Peat Rigg has extremely high standards of quality and safety. However, outdoor activities by their nature do contain some risk and all course participants should be aware of this and have some level of personal responsibility.
10. Risk Assessments are continually reviewed, and procedures revised if necessary.
11. Peat Rigg is under no liability whatsoever in respect of loss or damage to property.
12. A responsible adult of the booking party will have to be present during courses involving children or vulnerable adults.
13. By agreeing to these booking conditions, the group leader, on behalf of the booking organisation, also takes responsibility for the actions of their group. Any losses of equipment or wilful damage to the accommodation or equipment will be charged to the group.
14. Peat Rigg reserves the right to make a charge for unacceptable nuisance.
15. If the Centre is left in an unacceptable state of tidiness (beyond normal wear and tear) then Peat Rigg reserves the right to make an additional cleaning charge.

Health and Safety Considerations

16. Some activities require a reasonable level of personal fitness. Anyone with medical conditions must seek medical advice and, if relevant, inform Peat Rigg of any advised restrictions on their participation.
17. Course participants will not be permitted to consume alcohol or drugs prior to or during the course. Peat Rigg staff reserve the right to remove anyone from the course considered to be under the influence of drugs or alcohol.
18. This right to remove participants from the course will also include any action that endangers themselves or others or presents significant disruption to the course.

Disabilities

19. Peat Rigg are keen to encourage disabled persons to participate on our courses.
20. To help us to ensure that all participants can gain the most from each course, Peat Rigg staff must be informed of any medical conditions or any other special needs of any participant.
